Data briefs are created and posted based on input from a variety of stakeholders and are used for multiple applications. This specific data set was used during a health technology review process, initiated by the Bermuda Health Council. The data presented below are by topic, with specifics such as diagnoses codes and procedures codes often coming from the requestor. As a result, the same topic or condition may show different claims data, due to variability in coding selection. Additionally, as information is received, changes in data capture may occur, which may be corroborated by the dates of the request. Due to the nature of procedure coding, many codes are not mutually exclusive to a specific application or specialty, which means values for office visits, for example, may appear in multiple specialty analytics. Additional information is available, with regard to claim type and diagnosis to discern further follow up, as needed. Finally, analytics for "common" coding in any field are strictly based on identically matching values. It is possible other, frequent codes exist, but may not be captured if entered in multiple varied formats.
